# Indigenous Land Acknowledgement


- We respectfully acknowledge that we live and work in territories where indigenous nations and tribal groups are traditional stewards of the land. Our California office resides in Tongva territory.

#### What is homelessness?



- "People who are living in a place not meant for human habitation," such as cars, parks, sidewalks, or abandoned buildings.
- People who are living in an emergency shelter or transitional housing.
- People who "are exiting an institution where they temporarily resided."
- "People who are fleeing domestic violence" or other abuse and have no safe, alternative housing.

Being houseless can create a great deal of obstacles in those simple tasks, obstructing someone's ability to perform their best at school or work.


