

How is BHWD (PWI/EPOC) Enhancing and Expanding the BH Workforce in California

The California Department of Health Care Services (DHCS) Behavioral Health Workforce Development (BHWD) project is expanding California's behavioral health workforce to improve participant access to and productive participation in behavioral health services throughout the state.

BHWD's Expanding Peer Organization Capacity (EPOC) grant offers a rare opportunity for emerging peer organizations to build their infrastructure and capacity to deliver peer recovery supports for individuals with mental health and substance use disorders.

BHWD's Peer Workforce Initiative (PWI) provides a unique chance for behavioral health programs to invest in their capacity and infrastructure to "set the table" for the Medi-Cal peer support services benefit.

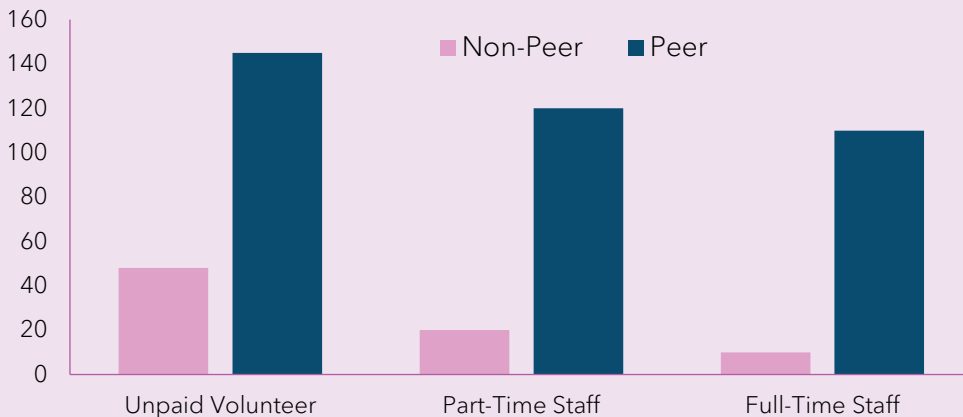

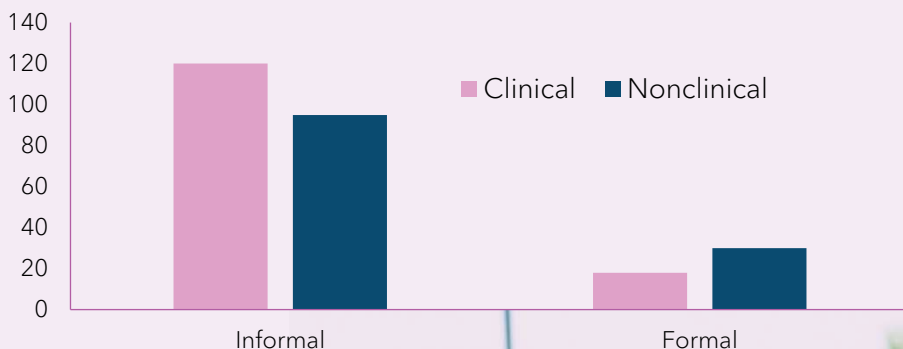

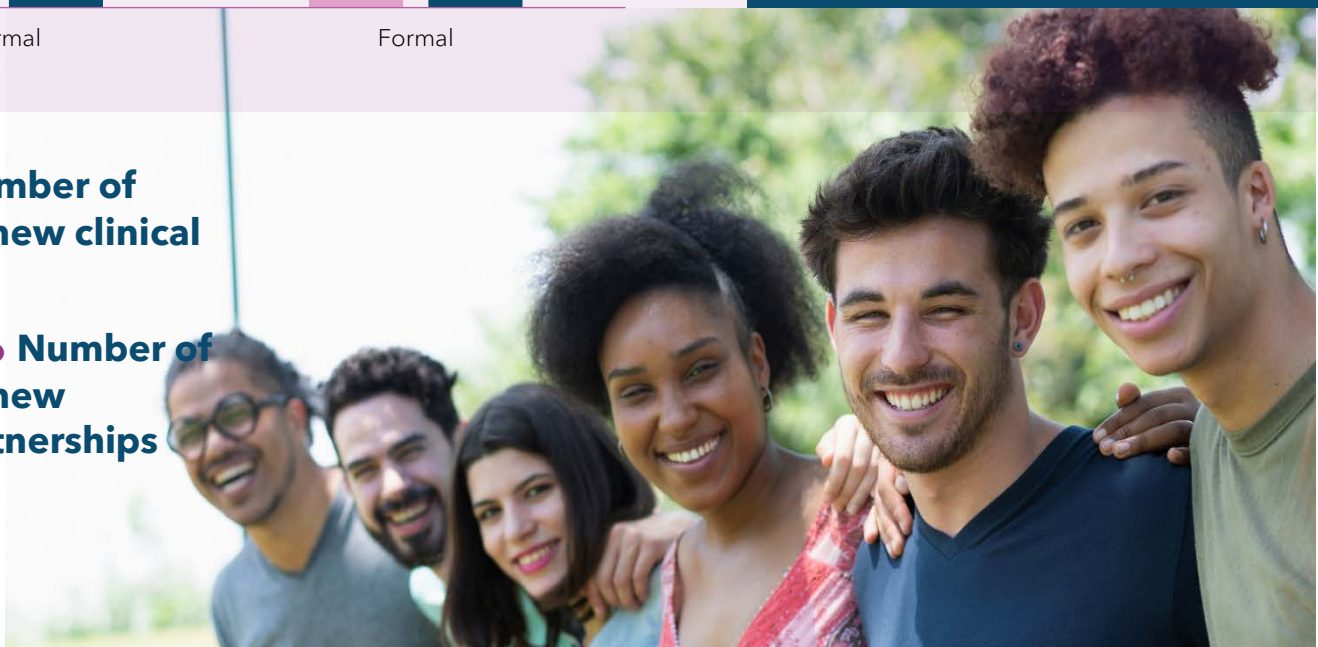
In Q4, we began partnering with the public defender's office to assist folks getting to court and negotiating sentencing, including not being charged a fee when given diversion.
