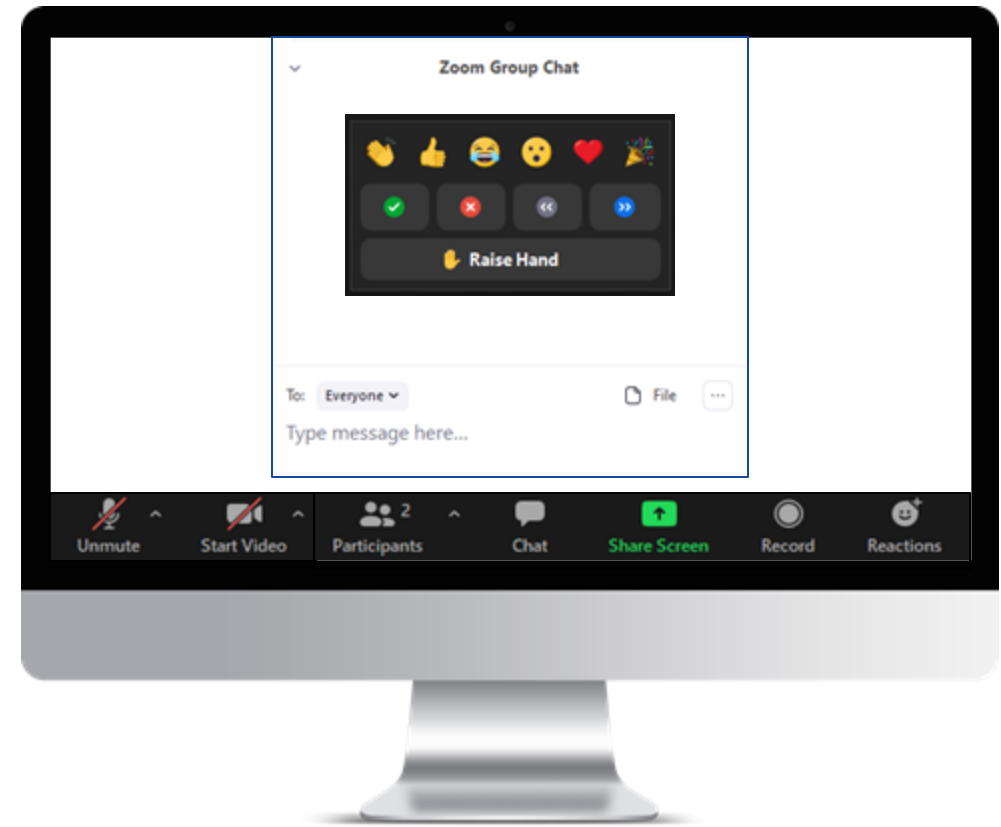

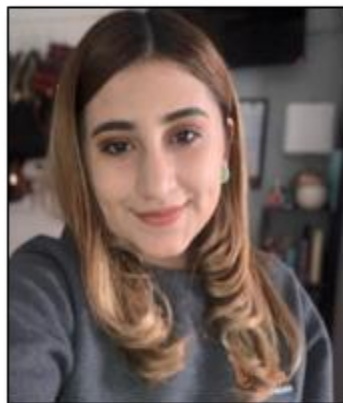

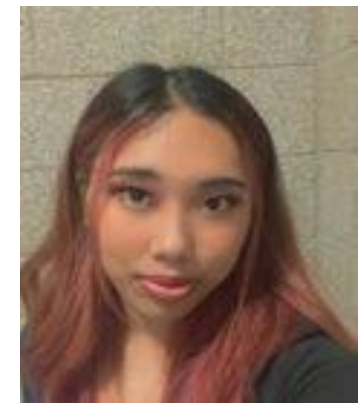

CALMHSA & Peer Certification Update

CALMHSA started offering exams on 12/13/22.

They now have 134 certified specialists- 12 failed to pass

The application for the grandfathering process was extended to June 30, 2023.

Finalize C schedule for scholarships- vendors providing scholarships will get a stipend. Vendors have no cap on what they will charge for the training.

Development of core competencies for the areas of specialization has been extended to June 30, 2023.

A RFP will be released this Spring for organizations to become approved vendors for the Peer Certification training for the state exam
