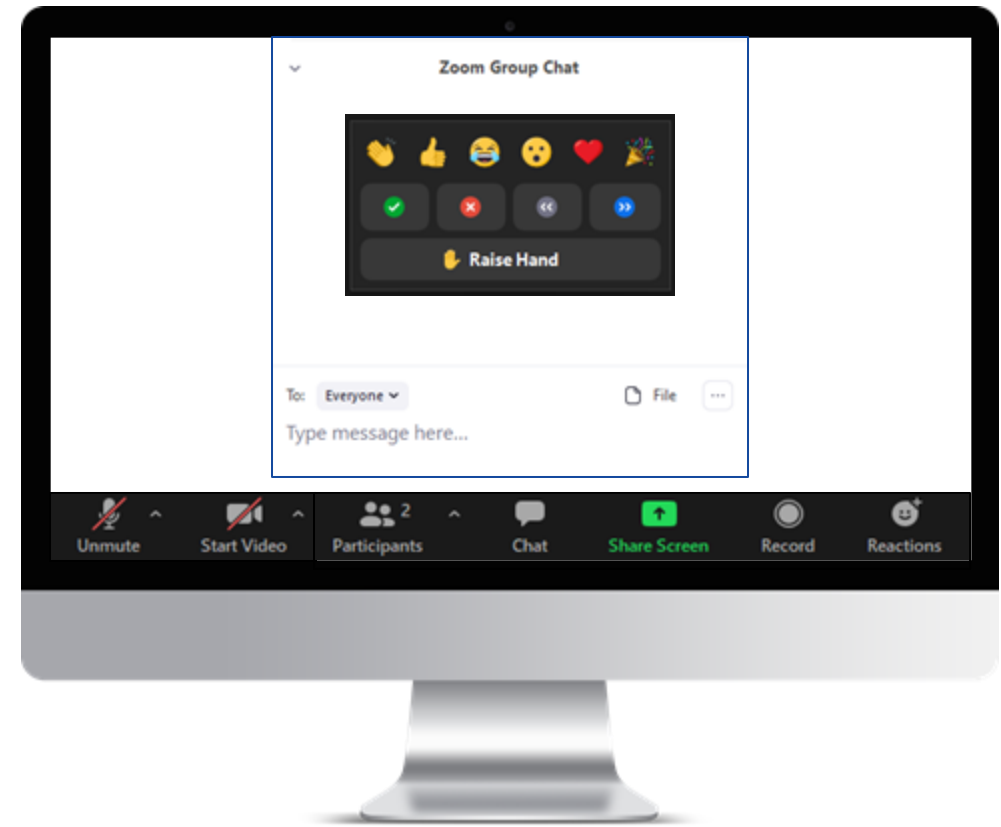

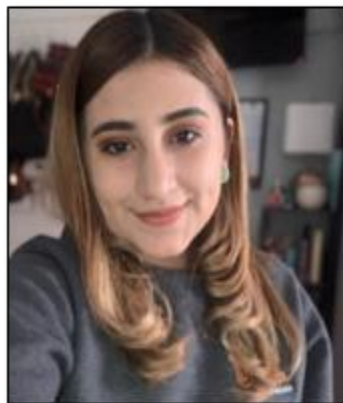

NCE Survey -Due ASAP-

NIH definition of No Cost Extension (NCE):

- “an extension of time to a project period and/or budget period to complete the work of the grant under that period, WITHOUT additional funds or competition.” This NCE would extend your period of performance from the original end date of 2/14/23 to 12/31/23, but you would not receive additional funds beyond what you have remaining to spend from your original award amount.

Purpose of the NCE Survey:

- We want to find out how you plan to spend down your funds now that the project has been extended.
- 2 questions added to discover how many peer staff intend to become certified as peer support specialists with CA

- Due by EOB on November 17th
