





## **Scholarships**

When will scholarships become available for community-based peers?

Currently open to all. They can apply on the CalMHSA certification website.

 Has the scholarship application deadline been extended beyond 12/31/22?

This date is obsolete. A person can apply for scholarship until scholarships are depleted.

## Other training information

When will the supervisory training be available?

By end of February 2023.

What is the fee for the training?

No Cost. Free to all.

For whom will it be available?

Open to all. The link to register for the training will live on the CalMHSA certification website. People will be required to register in order to fulfill the data collection requirements by DHCS.

## **Training Cont.**

- When will the specialty trainings become available?
   Parent, Caregiver, Family Member Peer training providers are finalizing contacts with CalMHSA. The competencies are posted.
  - Is there a fee for those?

\$1,600

Will scholarships be available for those?

250 scholarships per area of specialization. There are 4 areas of specialization (the above, Crisis, Unhoused, and Justice Involved). Core competencies for remaining 3 areas of specializations must be ready by July 1, 2023. RFP for training in these areas expected April/May.

## **Compliance & Attendance**

- Attendance requirement. In order to meet your contractual attendance requirement, you **must** have at least two staff members attend each **LIVE** mandatory event and fill out the attendance form, which is dropped in the Zoom chat at the end of each event.
- Grantees will no longer be allowed to "make-up" missed events if they did not attend the live event:
  - ➤ If you will be missing an event, GLs must be notified 2 weeks beforehand, and approved by GL/AHP.
  - Approval will only be given if 1) there is an event that prevents all grantee staff from attending, or 2) Grantee expresses that the event content is remedial for staff.
  - > We will notify all grantees if events are cancelled/changed, otherwise all scheduled event dates are set in place, and you must attend.
  - > All upcoming event dates and Zoom registration links will continue to be added to the site via the following link. YOU MUST BE SIGNED IN to view events.

## NCE & Round 2 Funding

- In order to be eligible for Round 2 Funding, you must complete the following requirements by April 15th, 2023.
  - Failure to do so will result in ineligibility for Round 2 Funding.
- 1. **MUST** attend all the remaining Q7-Q10 events **LIVE**. Attendance will only be counted if you stay until the end of the event and each staff member completes the attendance form dropped into the Zoom chat at the end of the event.
- 2. Q7 Invoice and Data Report MUST be submitted no later than the 4/15/23 due date.
- 3. MUST make progress towards the TTA Plan and submit updates once per quarter.
- 4. MUST respond to all communication from GL within 3 days of receipt.
