



Background



California Mental Health Services Authority


CalMHSA - Certifying Entity

The California Mental Health Services Authority (CalMHSA) is the certifying entity, responsible for certification, examination, and enforcement of professional standards for Medi-Cal Peer Support Specialists in California. All applicants seeking certification are required to successfully pass an exam, ensuring any individual holding a certification has met the minimum educational requirements. CalMHSA investigates consumer complaints and imposes disciplinary actions against a professional in violation of the Code of Ethics.

CalMHSA was elected by county behavioral health plans as the certifying body for the certification of Medi-Cal Peer Support Specialist.



Medi-Cal Peer Support **Specialist** Certification **Implementation**



- Opt-In to Peer Benefit
- Select Certifying Entity
- Update contracts/billing system for reimbursement

benefit

Has employer & contract oversight role

- Certifies Individuals
- Approves Training Entities
- Develops all "Board" functions, Exam, registration lookup, investigations, etc.
- Evaluates outcomes

Once certified, individuals can move across counites as part of certified workforce





Role of the Certifying Entity





Certification Requirements

Certification Requirements

- 1. Submit application on the CalMHSA certification website
- 2. Must be at least 18 years of age or older
- 3. Possess a high school diploma or equivalency degree
- 4. Self-identify as an individual with lived experience
- 5. Be willing to share own experience as a person with lived experience to help others in their recovery

- 6. Have a strong dedication to recovery
- 7. Agree, in writing, to adhere to the California Department of Health Care Services Medi-Cal Code of Ethics for Peer Support Specialists in California
- 8. Meet training requirement
- 9. Successfully pass the certification exam



Requirements

Grandparenting Certification

Meet previously stated requirements

AND must meet at least ONE of the following:

Option 1: One (1) year paid or unpaid work experience with a minimum accumulation of 1550 hours of experience in a peer role

Option 2: Minimum of 1550 hours in 3-years with 500 hours completed within the last 12-months, working as a peer (paid or unpaid)

AND must also meet <u>ALL</u> the following:

- 1. Submit application by June 30, 2023 (extended deadline)
- 2. Employed in a Peer role on 1/1/22
- 3. Complete 20 hours of continuing education (CEs), including 6 hours of law and ethics. CE course training shall have been taken in the last 2 years.
- 4. Completion of a Peer training. Peer training is defined as training focused on concepts of peer recovery and resiliency. Proof of completion is required.
- 5. Three (3) letters of recommendation (supervisor, colleague/professional, & self).

Initial Certification

Meet previously stated requirements

AND complete an 80-hour Medi-Cal Peer Support Specialist training from a CalMHSA-approved training provider.

 21 approved training providers available on the certification website



How to Apply

Application

- Register on the CalMHSA certification website (<u>www.CAPeerCertification.org</u>)
- 2. Complete application for certification
- 3. Must have met the requirements at the time of application in order to apply
- 4. Pay fee or scholarship application (based on availability)
- 5. Only complete applications will be processed

Certification Process

- 1. Reviews applications (30-day processing)
 - 1. Approves
 - 2. Asks for revision
 - 3. Denies
- 2. Notification: status of application
- 3. Notification: receive unique code to register for the certification exam (approved status)
- 4. Notification: certification document for those with passing scores

Grandparenting Application

DHCS extended deadline through June 30, 2023

Exam

- In-person test centers <u>and</u> on-line testing (Pearson VUE is exam proctor)
- Reasonable accommodations may be requested in advance of exam
- Additional languages to be added May/June 2023 (subject to change)

Fee Schedule

Approved by DHCS

Application for certification \$100

Certification exam \$150

Exam retake \$150

Certification renewal (2-years) \$ 80



Supervision of Peer Workers Available

- No cost
- Registration on certification website required
- Based on SAMHSA's best practice guidelines
- 1-hour self-paced training

Accepting Application for New Training Providers (Core Competency)

- Opened March 1, 2023
- No closing/sunset date
- \$300 non-refundable fee
- Must meet all requirements





Areas of Specialization (Crisis Care, Unhoused, Justice Involved)

Curriculum development extended by DHCS through July 1, 2023

CalMHSA has:

- Held focus groups with subject matter experts for input/feedback
- Input/feedback accepted through 3/24/23


Next steps:

Data Snapshot




Data Snapshot

- As of March 15th, 2023, the Peer Certification Program has garnered 3,222 applications.
- The majority (60%) of these applicants have taken the Initial Certification Path, while the remaining 40% have opted for the Grandparenting Path.
- Currently, 534 applicants have received certification for Medi-Cal Peer Support Specialists.




Demographic Data of Applicants






Demographic Data of Applicants






Demographic Data of Applicants




