



Funding Overview

- **BHRR** is a project of the DHCS BHWD Initiative.
- The goal of **BHWD** is to support and expand the statewide behavioral health (BH) workforce in California.
- **BHRR** is funded through the American Rescue Plan Act 2021.
- **AHP** serves as the Administrative Entity (AE) on behalf of DHCS to administer, supervise, and provide TTA to BHRR grantees.



Funding Opportunity Overview

Two Phases of Funding

Phase A: Planning Phase

- 3 months
- **\$50,000**
- Develop tailored implementation plan to expand recruitment and retention


Phase B: Implementation Phase

- 16 months
- Up to \$300,000
- Implement at least 1 recruitment and/or retention strategy



It is expected that grantees will be awarded funds in Phase B, depending on performance in Phase A.

The Four (4) Goals of BHRR

| Improve | Improve BH organizations' knowledge and implementation of best practices in BH workforce development and change management. |
|-----------------------|---------------------------------------------------------------------------------------------------------------------------------------------------------------------------|
| Strengthen | Strengthen BH organizations' capacity to effectively recruit and retain skilled staff through identification and deployment of specific strategies in their organization. |
| Increase Diversity | Increase the diversity of the BH workforce through an array of strategies to better reflect the individuals in need of services. |
| Long-term Strategy | Increase BH organizations' sustainability and ability to respond to changing environments by supporting the development of and adherence to longer-term strategic plans. |



BHRR Phase A Overview

Phase A (Planning Phase) July 1, 2023 – September 30, 2023

HCS

- Awarded grantees have received \$50,000 for Phase A (the three [3]-month planning phase).
- Unspent funds from Phase A can be rolled over into Phase B if grantee approved for Phase B.
- Extensive TTA will be provided during this phase to ensure monthly deliverables are met and a Phase B Implementation Plan is completed.
- Phase B budget is due on **8/21/23** to ensure time for review.
- Phase B Implementation Plan must be submitted during Phase A by **9/29/23**.
- Grantees are **required** to participate in TTA opportunities.




BHRR Phase B Overview

Phase B (Implementation Phase) October 1, 2023 – January 31, 2025

- Awarded grantees will receive up to \$300,000 for recruitment and retention strategies. The amount will be determined based on the Implementation Plan and budget completed during Phase A (Quarter 1).
- The final budget for Phase B will be developed as part of the Phase A three (3)-month Planning Phase and will be approved and awarded via a subcontract modification.
- Grantees must complete a Sustainability Plan during Phase B, which must be referenced in the Implementation Plan.



New Grantee Process

- AHP Grantee Coach assigned to each BHRR grantee.
- Grantee onboarding (survey completion, asynchronous training).
- SOW and subcontracting process with AHP.
- Grantee Coach will work with each site to develop the SOW and execute the grantee subcontract for each phase as soon as possible. This timeframe varies by the grantee.

The funding start date is July 1, 2023.



BHRR Grantee Requirements

Develop subcontracts with AHP and execute them ASAP. Complete Phase A workplan and meet all deliverables needed to receive Phase B funding.

Implement projects as specified in the Implementation Plan and SOW, including TTA participation (all part of the subcontract). Participate in data collection, outcome monitoring, and evaluation related to BHRR objectives (specified in the subcontract). Submit quarterly reports with data updates and deliverables progress.

Submit quarterly invoices.

First Tasks For BHRR Grants



Identify a BHRR Coordinator for grantee sites and solidify executive leadership support for project.



Develop the SOW. AHP's SOW template will be sent to the BHRR Coordinator by July 6, 2023.



Complete BHRR assessment surveys. Links will be sent to the BHRR Coordinator by July 6, 2023.

Complete the BHRR Phase A workplan. A template will be sent to the BHRR Coordinator by July 6, 2023.

Attend the July 11, 2023, 12 p.m. – 1 p.m. PT Administrative Launch webinar for SOW, contracting, and invoicing information.



Re-examine the budget to ensure that tasks and budget align. A Grantee Coach will work with the BHRR Coordinator to assist in SOW completion and subcontract execution.




