





Medi-Cal Billing

- The PWI and EPOC team will submit a peer support specialist Medi-Cal billing "road-block summary" report to DHCS at the end of this month.
- Please submit any narrative feedback on how your organization's experience with the Medi-Cal billing process has been, including any issues, challenges, or obstacles.
- Until more information is provided on Medi-Cal billing by DHCS, the PWI and EPOC team will be putting together resources to distribute to grantees.





AHP Auditing Process

- Per the request of DHCS, the AHP Finance Department will start selecting PWI and EPOC grantees for auditing this week.
- Auditing will start with the oldest PWI grantees with the largest award amounts. A handful of grantees will be audited every few months.
- The desk audit will be remote and will focus on compliance with subcontractor agreements.
- Grantees will be notified by the AHP Finance Department via email once selected for the auditing process and additional guidance will be provided at that time.

Training and Technical Assistance (TTA) Requests

- The <u>Grantee Request Form</u> is a tool PWI and EPOC grantees use to receive tailored support.
- Requests can include administrative support, technical support, and individualized TTA.
- A new TTA menu has been added to help grantees better understand the kinds of support that Faces & Voices of Recovery and our AHP subject matter experts can provide.
- Participating actively and using the TTA resources effectively are a required deliverable for the PWI and EPOC grant.

Regional Open Forum Calls

- The PWI and EPOC team will be launching a series of optional Regional Open Forum Calls.
- These calls will provide a space for grantees to connect regionally, collaborate, share information, ask questions, and discuss best practices with one another.
- There will be three calls during the 18-month grant period (fall 2023, spring 2024, fall 2024), each focused on a different topic.
- Grantees will be assigned a region and a subregion based on their location in California.
