



#### **PWI and EPOC Data Updates**

- Reminder: All grantees should be collecting and tracking data <u>now</u> for the next Quarterly Data Report (QDR), due January 15, 2024.
- If you do not have your own means of collecting and tracking data, please use our <u>QDR Tracking Sheet</u> to gather all the necessary information in one place.
- Reminder: It is the Program Coordinator's responsibility to ensure this information is being collected throughout the reporting period and will be ready to copy and paste into the QDR in the portal at the end of the reporting period.

#### **Financial Worksheet Update**

- The submission deadline has been postponed to March 31, 2024.
- Grantee Coaches will be updating the deadline in your Implementation Plans.
- Grantees will receive the Financial Worksheet by January 31, 2024.
- The worksheet will be used as a guide to support sustainability. It will help determine where your organization is financially, identify where you want to be, and propose next steps for how you will get there.
- More guidance and a detailed timeline will be provided at the December Administrative Coaching Call.



#### **Resource-Sharing Protocol**

- To maximize the sharing of relevant resources, the following protocol has been put in place:
  - Grantee → Grantee: Grantees will use the Public Facing Roster on the PWI/EPOC General Hub to distribute resources via email to other grantees.
  - Grantee Coach → Grantee: Grantee Coaches will provide resources to grantees during the monthly
     1:1 meeting or via follow-up email.
  - PWI/EPOC Team → Grantee: Grantee Coaches will include any resources that have been provided to individual grantees in the next PWI/EPOC Newsletter so that all grantees receive them.
  - Grantee → PWI/EPOC Team: Grantees will send relevant resources to the BHWD Inbox. The PWI/EPOC team will include resources in the next PWI/EPOC Newsletter so that all grantees receive them.
